**Week of July 1, 2013 to July 7 2013**

**Monday, July 1, 2013**

- Two motor vehicle accidents were reported and six arrests were made on this date.
- An officer responded to a report of a Larceny at 2601 E. Kalamazoo St, Village Party Store. The complainant reported that a known female subject had borrowed his bike the previous night and in the course of her using it, it was stolen from outside of this location. The bike was described as a gray Giant 21-speed mountain bike with a locking mechanism attached to the frame.
- At W. Michigan Ave near Western Ave, officers reported arresting a male subject for Receiving and Concealing Stolen Property, Operating without a Valid License, and Possession of an Unregistered Motor Vehicle. The subject was operating a yellow and white Wildfire moped that had been reported stolen out of East Lansing Police Department. The subject was lodged at Ingham County Jail.
